

TĪMATANGA INITIATE

GRANT PROPOSAL



This grant funds early-stage AUT research where there's an outside collaborator wanting to use the research outcomes. The grant's goal is to create future commercialisation and impact opportunities.

Is this grant a good fit for your project?

If you've identified a real-world problem that can be solved with some research and have a non-academic collaborator that wants to help bring your solution to life, then this grant may be for you. The Timatanga Initiate grant can be used for normal research costs like prototyping (materials and services), research assistant time and travel. The project should be aiming to reach an outcome that can be used by the collaborator directly, or to create a proof-of-concept that needs further development.

Criteria

A credible collaborator & a pathway to realisation

The application will be assessed largely based on **the level of support the project has from a credible non-academic collaborator from outside AUT**. What we're looking for is confidence that the collaborator has deep experience of a real-world problem, and is genuinely committed to using the project results to solve it – if the project is successful.

Collaborator commitment would usually be signalled by buy-in from top decision-makers, alongside significant in-kind or financial contributions. Strong proposals (especially those at the upper end of the allowed project costs) will include formal commitment from the collaborator, such as a letter of intent. (AUT Ventures can help you with the pre- and post-project discussions with your collaborators.)

Where the collaborator is a **business**, good proposals should be able to show an intent to buy or license the intellectual property if the project is successful. Projects with individual entrepreneurs might work, if the entrepreneur is experienced in the relevant market, committed, and has a credible go-to-market plan.

Where the collaborator is **non-commercial, such as government, public sector, or community groups**, the Timatanga Initiate Grant should lead to better wellbeing or other outcomes for stakeholders, patients, clients, members etc. Good proposals will show a clear intent, as well as the capability and authority to adopt and implement the research outcomes in policy or practice.

Sometimes the Timatanga Initiate Grant might fund a proof-of-concept that leads to a further, larger grant proposal with other funders. In this case, the outside collaborator would be expected to actively support that future project too.

Relationship with other sources of funding

The Timatanga Grant is not intended to compete with other funding. However, where research has already been done, it might be that KiwiNet commercialisation funding is a better option. Before developing a Timatanga Initiate Grant application, please **check with the AUT Ventures team to see whether KiwiNet might be a better option for you.**

Available funding

The Timatanga Initiate Grant is aimed at projects from \$5k to \$40k in cost. Multiple projects will be funded, but the number will change year to year.

Because the grants will be allocated a first-come-first-served basis, **we strongly advise you to check the current status with us at ventures@aut.ac.nz** before starting to prepare an application.

Help with your proposal

AUT Ventures can help you with at least two aspects of your application:

- helping you and your collaborator plan how the project outcomes would be turned into a sustainable product or service if the project is successful; and
- understanding what intellectual property (IP) will be needed, created, and protected for the project.
